By creating an account, becoming a member (Standard or Premium), or accessing any part of our Website, you agree to be bound by these Terms.

If you do not agree with any part of these Terms, you must not use our Website or services.

#### 1. About Us

Uzbekistan's Student Union is a student organisation registered in Uzbekistan, with its headquarters in Tashkent. All subscription plans and payments are processed and managed through our UK-based operations.

### 2. Membership Plans

### 2.1 Standard (Free) Membership

Standard members gain access to:

- General member updates and announcements
- Invitations to general and skill-building events
- Job opportunity updates
- Networking and cultural events open to all members

#### 2.2 Premium (Paid) Membership

Premium members receive, in addition to Standard benefits:

- Access to exclusive premium-only events
- Priority event registration
- Discounted tickets for selected events
- Premium members' group chat and networking channels
- Discounts from our partner organisations

Premium membership is available on a **monthly or annual** basis and must be paid via Stripe or any other payment method offered on our Website.

### 3. Eligibility and Accounts

Membership is open to students and alumni.

There are **no age restrictions**; however, users under the age of 18 are assumed to have parental or guardian consent.

Each user must create an individual account with their full name and email address.

You are responsible for maintaining the confidentiality of your account and password and for all activities conducted under your account.

#### 4. Payments and Renewals

All Premium membership payments are processed through **Stripe**, which accepts major payment methods (credit/debit cards and others).

- By subscribing, you authorise us to charge your payment method on a recurring basis (monthly or annually, depending on your chosen plan).
- **No refunds, cancellations, or partial refunds** are provided under any circumstances, including failure to attend events or dissatisfaction with membership benefits.
- You may stop renewal at any time before your next billing date, but previous payments remain non-refundable.

We reserve the right to change membership prices at any time with prior notice.

### 5. Data Collection and Privacy

We collect limited personal data—specifically, your **name** and **email address**—to administer your membership and communicate with you.

We comply with the **UK GDPR** and applicable data protection laws.

### 6. Member Conduct and Usage Rules

- You must not share, resell, or transfer your membership account or access credentials to anyone else.
- Membership benefits are strictly personal and non-transferable.

- We reserve the right to suspend or permanently terminate accounts found in violation of these Terms, without refund.

All materials, resources, and content shared with members are owned or licensed by Uzbekistan's Student Union and must not be copied, redistributed, or used for commercial purposes without written permission.
